

# Standards of Business Conduct Annual Report 2020/21

#### 1. Introduction

- 1.1 The Standards of Business Conduct (the Standards) were revised and approved by the Board of Directors in December 2018 at which point Board members requested that the length of the main document was shortened prior to its dissemination across the Trust. The Standards were further revised and the length of the main document (excluding appendices) was reduced from 43 pages to 12. This shortened version of the Standards was approved by the Board of Directors at its 28 May 2019 meeting and then disseminated across the Trust.
- 1.2 A further revision to the Standards was made during 2020 in order to enable the Trust to move to an electronic system of declarations and was approved by the Board of Directors at their meeting in August 2020.
- 1.3 During 2020/21 the focus has continued to be on ensuring all colleagues understand their obligations to adhere to the Standards as well as their obligations under NHSE's Conflicts of Interest guidance. The Medical Director and the Head of Governance led a proactive exercise to increase the declarations made by the Consultant body during the year.

#### 2. Background

- 2.1 The Standards outline the principles by which decisions are made by the Trust, its management and staff and through which they can be held accountable. Best practice guidance for business activities is included within the Standards in addition to advice as to how colleagues may raise concerns, and how such concerns will be dealt with, if an individual believes these practices are not being followed.
- 2.2 Specific guidance is provided for the declaration of gifts, benefits, hospitality or sponsorship, all of which should be declared and registered if they amount to more than £25. Gifts must also be declared if several small gifts from the same, or closely related source, total more than £50 in a 12-month period.
- 2.3 A strong corporate responsibility programme is engendered throughout the organisation through adherence to the Standards, which ensures that the Trust's business remains well within legal requirements. All employees are able to feel confident about the Trust's standards of business practice because their working environment is geared towards adherence to the Standards. The Standards enable the Trust to continue to achieve financial and operating results whilst adhering to high ethical standards which guide relationships with service users, employees, external partners and local communities.
- 2.4 Effective communication of the Standards throughout the organisation ensures that all colleagues understand their responsibilities in relation to the Standards of Business Conduct and related policies and procedures and is crucial to the adherence to, and compliance with, ethical business practices (and as a result, the relevant legislation and regulation). During 2020/21 the Head of Governance continued to lead an awareness raising campaign designed to ensure all colleagues are aware of the Standards and their obligations under NHSE's Conflicts of Interest guidance. Table 1 highlights the awareness campaign during 2020/21.

- 2.5 During 2020/21 the Head of Governance continued to lead an awareness raising programme across the Trust in relation to NHSE's Conflicts of Interest guidance and the Standards. This included:
  - Articles in two of the 'all users' Communications messages in January 2021 relating to the acceptance of gifts
  - Reminders in 'all users' Communications messages in January 2021 and on three consecutive weeks in March 2021 requesting that 'decision making staff' made their annual declaration of interest returns before 30 March 2021
  - Targeted messages to decision making staff from the Head of Governance, Medical Director or Chief Nurse to all colleagues who needed to make an annual return but had not done so by 30 March 2021 in April, May and June 2021
- 2.6 In addition, the Standards of Business Conduct and Conflict of Interest webpages on The Hub were updated during 2020/21 to maintain the easy access for all colleagues to the shortened Standards and the appendices containing the two different declaration forms. The pages were also updated ahead of the go live of the electronic declaration of interest process to provide guidance to colleagues about how to declare their interests or make a nil return using the electronic system and to remove the declaration of interest form which had been replaced by the electronic system.

#### 3. Overview of Achievements during the period 2020/21

3.1 The main achievement during 2020/21 was the launch of the electronic declaration of interest process via the Electronic Staff Record (ESR) system on 01 September 2021. The go live had originally been planned for April 2020 but was delayed due to the COVID-19 pandemic. The other achievement of note was the increase in the number of declarations of interest or nil returns received from decision making staff. This was as a result of the introduction of the declaration of interest module of ESR which enabled:

- Automated messages from ESR on a quarterly basis to all decision making staff reminding them to make their declaration
- Regular reminders from the Medical Director reminding all Consultants that they needed to make an annual declaration of interest return
- Targeted messages to individual decision making colleagues who had not made their annual return from the Head of Governance, Chief Nurse and Medical Director reminding them that they were required to make their annual returns by set deadlines
- 3.2 The Company Secretary and the Head of Governance were contacted during the year on numerous occasions for advice by colleagues from a variety of professional groups.
  - 26 declarations were made during 2020/21 for gifts, benefits, hospitability or sponsorship using the Standards of Business conduct declaration form. This represents a decrease of 51 declarations compared to 2019/20 and is considered to be due to the impact of the COVID-19 pandemic. Of these 2 were declined by the Head of Governance, 19 were approved and 5 were retrospective notifications. For further details, please see appendix 1.
  - 302 declarations of interest were made relating to the 2020/21 financial year and were added to the Register of Staff Interests. This represents an increase of 41 declarations of interest compared to 2019/20<sup>1</sup> and is as a result of the actions detailed in section 3.1 above.
  - The Trust continued to meet the NHS England deadlines for the publication of the Register of Staff Interests on its internet site. For further details, please see appendix 2.
  - The Post Graduate Medical Education department (PGME) did not record any sponsorship during 2020/21 for the PGME Tuesday lunchtime lecture programme (compared to 25 occasions during 2019/20)
  - PGME did not record any sponsorship of lunches from companies for the weekly Acute Medicine Teaching Programme (compared to 25 occasions during 2019/20)
  - PGME did not record any sponsorship of lunches from companies for the weekly Grand Rounds Teaching Programme (compared to 36 occasions during 2019/20)

The reduction in sponsorship reported by PGME is due to the fact that most of the teaching during 2020/21 was delivered virtually due to COVID-19.

<sup>&</sup>lt;sup>1</sup> The 2019/20 Standards of Business Conduct Annual Report measured the number of individuals who had made a declaration (168) as opposed to the number of declarations made (261) since some individuals made more than one declaration of interest. In order to provide comparative data the number of declarations made in 2019/20 and 2020/21 has been reported in this Annual Report.

3.3 All new employee contracts include a reference to the Standards i.e.:

#### Standards of business conduct

You have a responsibility to declare any private interest which conflicts, or appears to conflict, with your NHS duties. Where appropriate to your job you are required to comply with the Standards of Business Conduct for NHS Staff (HSG(93)5), a copy of which is available from the Department of Health Website <u>www.dh.gov.uk</u> / or the Human Resources Department.

The Trust operates a zero-tolerance approach to bribery and corruption. It is a condition of your continued employment with the Trust that you comply with all applicable legal requirements relating to anti-bribery and anti-corruption including the Bribery Act 2010. Your employment will be summarily terminated in the event that you are found to have failed to comply with the requirements of the Bribery Act 2010.

In addition, the corporate induction information booklet informs all new colleagues that they must declare any material interests as soon as they join the Trust and within 28 days of a new material interest arising.

- 3.4 Those colleagues involved in procurement at the Trust are provided with advice to ensure they act in accordance with the Supplies Code of Conduct regarding their receipt of incentives e.g. loyalty points, colleagues' contact with company representatives etc. This advice is formalised through the inclusion of guidance relating to the Trust's Standards of Business Conduct and reference to the Chartered Institute of Purchasing and Supply Code of Conduct within the Trust's 'Policy and Guidance for the Procurement of Goods, Services and Works (Procurement Policy)'.
- 3.5 As evidenced in table 1 above, the Head of Governance and the Communications Team have continued to work jointly during the year to maintain a Trust-wide communications plan to publicise both the Standards and NHS England's Conflicts of Interest guidance. The plan included (but was not limited to):
  - Refresh of the dedicated intranet pages for Standards of Business Conduct and Declaration of Interests
  - Circulation of 'all e-mail user' communications relating to Standards of Business Conduct declarations
  - Reminders to all staff to complete declaration of interest forms if applicable and to decision making staff to complete their annual returns

#### 4. The Way Forward for 2021/22

- 4.1 The awareness raising programme will continue during 2021/22 focussing once again on ensuring all decision making staff complete their annual declarations in conjunction with the relevant Executive Directors.
- 4.2 All Trust policies are required to identify how adherence to the policy will be monitored and this includes those policies referenced within the Standards. The work of the Counter Fraud Specialist and Internal Audit are complementary to the Trust's own work programme to promote adherence by all colleagues to these Standards.

#### 5. Breaches of NHS England's Conflicts of Interest Guidance

5.1 NHS England's Managing Conflicts of Interest guidance which came into force in June 2017 notes that:

'There will be situations when interests will not be identified, declared or managed appropriately and effectively. This may happen innocently, accidentally, or because of the deliberate actions of staff or organisations. For the purposes of this guidance these situations are referred to as 'breaches'.

The guidance recommends that a report on such breaches is received by the governing body, Audit Committee or Executive Team on a regular basis to ensure that lessons are learnt and that the management of interests continually improves. The Trust's Standards of Business Conduct state that the Audit Committee will receive such breach reports on at least a six-monthly basis. The most recent such report was received by the Audit Committee in January 2021

During 2020/21 zero breaches were reported to the Company Secretary, Head of Governance or Counter Fraud Specialist.

#### 6. Conclusion

6.1 Overall the impact of the Standards on the declaration of gifts, benefits, hospitality, sponsorship and interests has been positive as evidenced by the number of declarations made, and enquires received, relating to the both the Standards and conflicts of interest in year. As mentioned above, the Standards are underpinned by several Trust policies therefore publication of articles explaining the relevance of the policies to the Standards serve to enhance colleague awareness and increase understanding.

#### 7. Action required by the Audit Committee

  - Approve this annual report and support the further work to be undertaken to safeguard ethical business practice in the future

#### Register of Staff Interests 2020/21

The published version of the Register of Staff Interests does not include declarations from staff who are not 'decision making staff' and who have not consented to the publication of their information. Nor does this version include declarations from 'decision making staff' where the publication of this information would put the individual at risk of harm.

Currently the declarations of interest or nil returns from all decision making staff are not included in this register. The numbers of decision making staff who have made their declarations of interest or nil returns has increased since 2019/20 due to the launch of the electronic declaration system in September 2020 which enables the Trust to remind decision making staff that they need to make their annual declarations. The Trust will continue to work with decision making staff during 2021/22 to further increase the number making their declarations of interest / nil returns.
